[PROPOSED] ORDER GRANTING PLAINTIF ATTORNEYS' FEES, COSTS AND SERVI	

The Court, having considered Plaintiffs' Motion for Attorneys' Fees, Costs and Service Awards (the "Motion"), and noting that no opposition has been filed to the Motion by Defendants or any Settlement Class Member, finds and Orders as follows:

- 1. The attorneys' fees requested are presumptively reasonable as they represent 35% of the common fund created by the Settlement. Multiple law firms, highly experienced in class action litigation and handling data breach cases worked on this matter in multiple jurisdictions/courts, and worked cooperatively and efficiently together, ultimately achieving the underlying settlement. This matter presented novel issues and high risks for Class Counsel, including the potential payment of Defendants' attorneys' fees in the event Class Counsel did not prevail in the various underlying matter(s). The high number of Class Members also required Class Counsel to litigate this matter carefully, utilizing great skill, efficiently and creativity. That Class Counsel performed quality work on this matter and achieved an excellent result supports their fee request. The Court, thus, grants Class Counsel's request for \$2,852,500 in attorneys' fees.
- 2. The \$76,536.77 in requested costs and expenses are reasonable and were necessary for the resolution of this case. The Court further grants this litigation cost reimbursement request.
- 3. The Court grants Plaintiffs' request for Service Awards in the amount of \$2,500 apiece for Plaintiffs Paula Henderson, Shykira Scott, Daniel Jones, Carol Goldberg, Vahram Haroutunian, Brian Kearney, Hilda Lopez, Preference Robinson, Sharon Etchieson, Radhe Banks, Jonathan Trusty, Marie Netrosio, Michaela Mujica-Steiner, Roger Loeb and Kyle Denlinger. The Court also grants Plaintiffs' request for Service Awards of \$1,000 apiece for Plaintiffs Martin Coleman, Alyssa Halaseh, Rachel Hunter, Todd Valentine and David Moynahan. These Service

Awards are reasonable and are warranted in light of the work performed and risks taken by each of the Plaintiffs on behalf of the Class.

4. As the requested attorneys' fees, expenses, and service awards are reasonable, and there being no objection to them, the Motion is hereby **GRANTED**. Class Counsel are awarded \$2,852,500 in attorneys' fees and \$76,536.77 in costs. The Class Representatives are granted the requested Service Awards, as described above.
